6.3.1 The institution has performance appraisal system, effective welfare measures for teaching and non-teaching staff and avenues for career development/progression

Performance Appraisal System:

The institution has been collecting the Performance Appraisal from teaching faculty members at the end of the academic year. The Performance Appraisal form or Self Appraisal form consists of the parameters related to Teaching and Learning, Research development activities, Students Support and Student Progression duties, Continuing Education, Administrative Duties. After the self assessment by the faculty members, the Performance Appraisal form shall be evaluated by Assessment Committee, which will be based on the verification of the proofs. The report shall be submitted to the Principal.

Welfare measures:

The Institution has been implementing welfare measures to both Teaching staff and Non-Teaching staff. It has been providing Employee Provident Fund for Teaching staff and ESI for Non-Teaching staff. Institution also provides Group Health Insurance to all the staff members as per Insurance guidelines. Institution provides Gratuity to the staff members, who completes a minimum of Five years service. The Institution provides maternity leaves for female teaching staff members.

Ten Casual Leaves per one year are permitted to all the teaching and Non-Teaching Staff members.

Seven Medical Leaves per one year are permitted to all the teaching and Non- Teaching Staff members subject to the submission of the Medical Certificate from the Doctor.

Female staff members are eligible for thirty Days paid Maternity Leave. But they will be given six months Maternity Leave without pay. Their service shall be considered.


