Discussion Points:

- Prof K.C Reddy has emphasized that the Boards of Studies (BoS) are to be constituted at the earliest.
- Prof.K.C.Reddy advised that the institutional roadmap should be designed with a 3 to 5 year vision, keeping future academic, administrative, and development goals in mind.
- Dr. V Padma Rao recommended organizing FDPs, such as those conducted by NITTTR, to enhance teaching competencies.
- Sri.L Prem Chandra Reddy and Prof K.C.Reddy stressed the need for faculty training, empowering teachers to empower students.
- Prof. V. Balmohan Das suggested appointing a Dean (Academics) to ensure a smooth transition into autonomy.
- Prof. P Srinivas Kishore recommended for starting new B.Tech Course in Mechanical Engineering
- Prof K C Reddy , Prof P Srinivas Kishore, Ms M Lakshmi and Mr V Padma Rao suggested additional Academicians and industry experts to be considered for inclusion in the Academic Council and BoS.
- The Principal requested the GB to nominate a member for the Finance Committee.

Agenda Item 5: Any other matter with the permission of the chair.

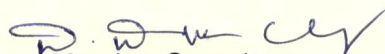
Principal proposed to consider for approval for merging all AICTE courses on the campus in Dr Lankapalli Bullayya College of Engineering(Autonomous)

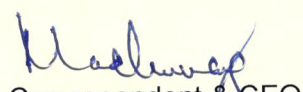
All the members unanimously approved for merging of all AICTE courses on campus in Dr Lankapalli Bullayya College of Engineering (Autonomous).
